<u>Approval of Agenda</u>: Moved by Menge, supported by Tikkanen to approve the agenda as presented. <u>Motion carried</u>.

<u>Approval of Minutes - (March 20, 2023)</u>: Moved by Peretto, supported by Nousiainen to approve the minutes as presented. <u>Motion carried</u>.

<u>Computer equipment purchasing</u>: Wuorenmaa informed the commission about purchasing new computers for the office. Wuorenmaa was originally considering about purchasing new computers for the whole office but instead will purchase them as needed.

Regional Housing Partnership (RHP) overview and authorization: Wuorenmaa explained the MSHDA program to the commission. WUPPDR has been selected to be the lead agency with a grant allowance of \$175,000 over a

two-year period. Moved by Tikkanen supported by Menge to recommend to the full board the approval and proper signatures for the Regional Housing Partnership grant agreement from MSHDA. <u>Motion carried</u>.

<u>MDOT 2024 Master Agreement approval and authorization</u>: Moved by Nousiainen, supported by Peretto to recommend to the full board approval and authorize proper signatures for the MDOT 2024 Master Agreement. <u>Motion carried</u>.

<u>Chiantello nominees</u>: Hyttinen requested everyone start thinking about candidates for this award and send their nominations to her by the August meeting. Hyttinen will email everyone the criteria for their information.

<u>Annual Meeting</u>: September 18. Hyttinen requested information from the Americann in Silver City and also Konteka in White Pine. Americann was quite a higher cost than Konteka so the annual meeting will be at the Konteka. Wuorenmaa asked Highland Copper to be the guest speaker and is waiting for their response.

<u>Other Business</u>: Peretto inquired about the arrangement of the meetings and why the Executive Committee meets separately before the Full board. She was given reasoning and the subject concluded.
