<u>Proposed General Fund Expenditures</u>: Wuorenmaa informed the committee the personnel policy manual is getting an upgrade, which may include contacting an attorney for legal advice, the WUPPDR website needs an update and he may request at a later date, which may cost approximately \$15-20,000.

<u>Project Updates</u>: Wuorenmaa stated the hazard mitigation plans exceeded the estimated time and cost and he has already requested an amendment increase. Houghton and Gogebic plans have been completed.
